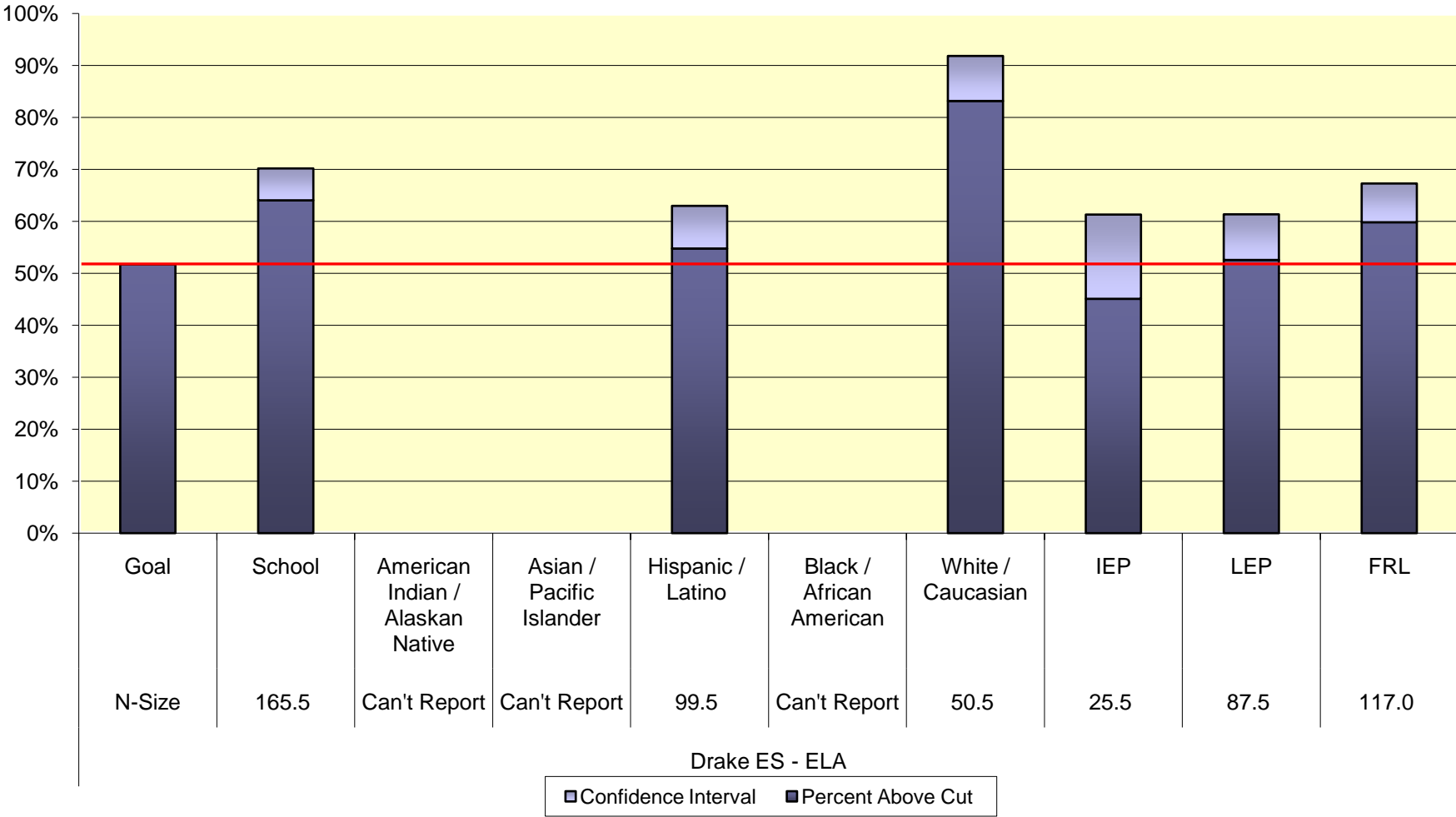

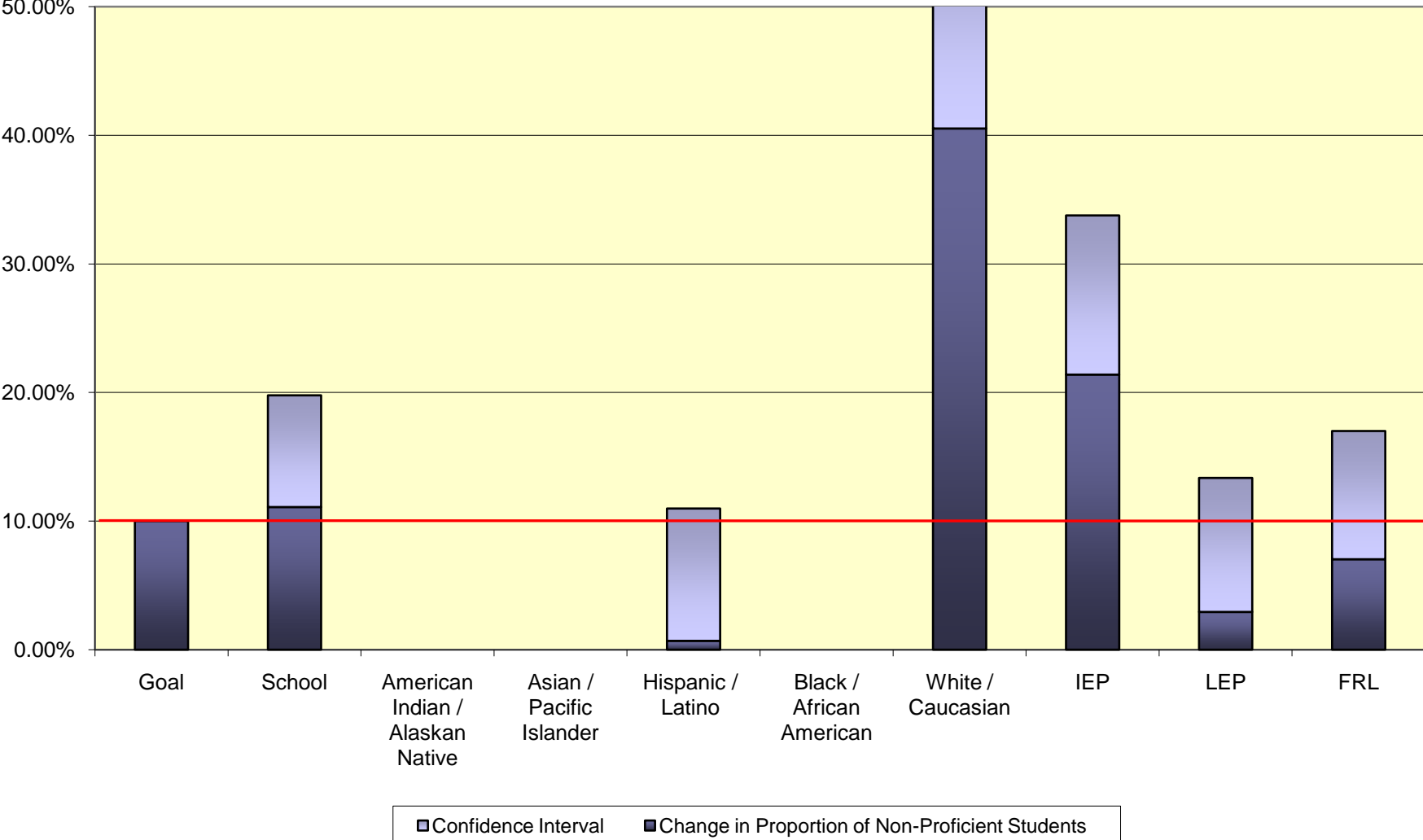

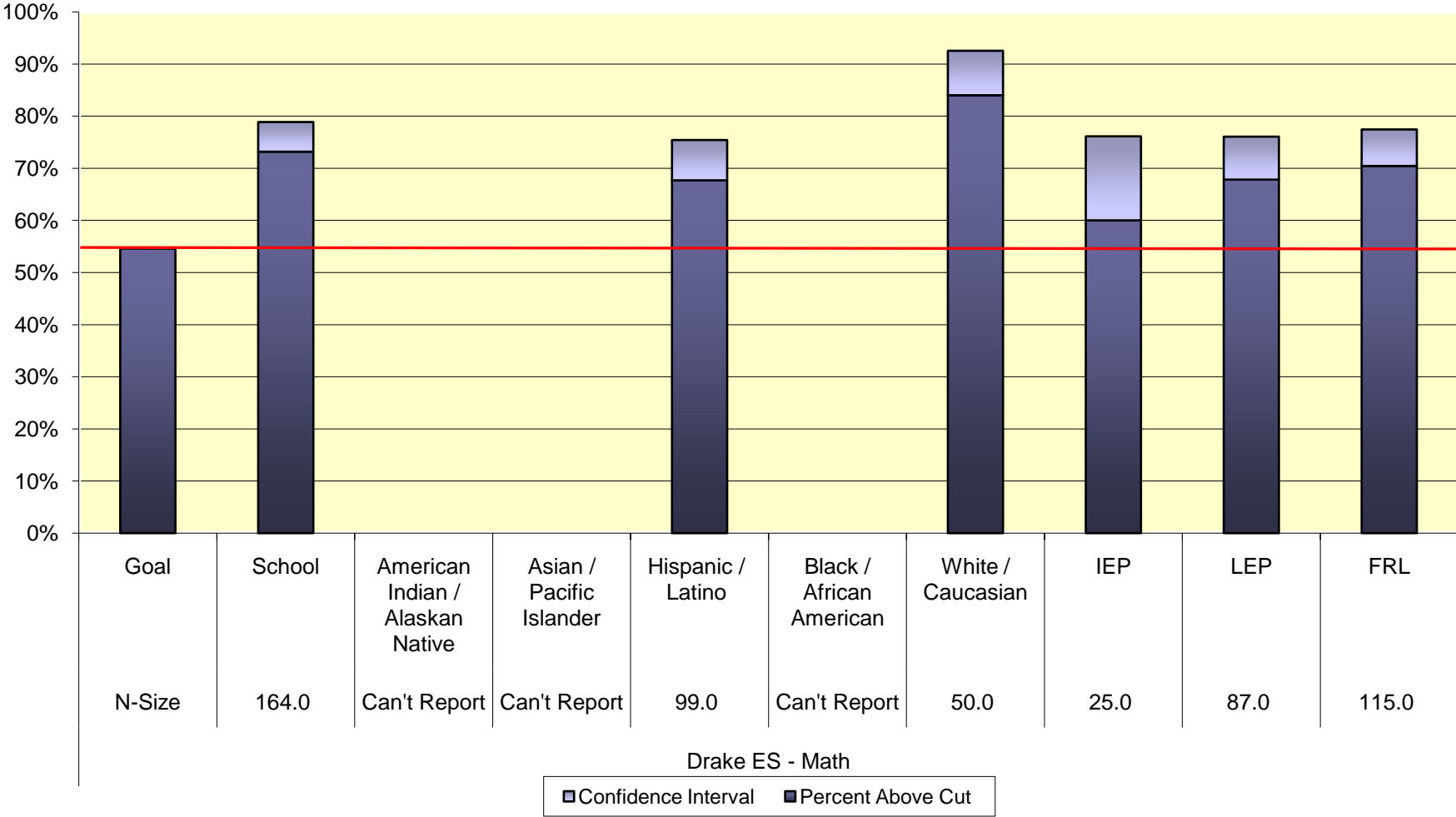
## 2008-2009 School Year ELA Status



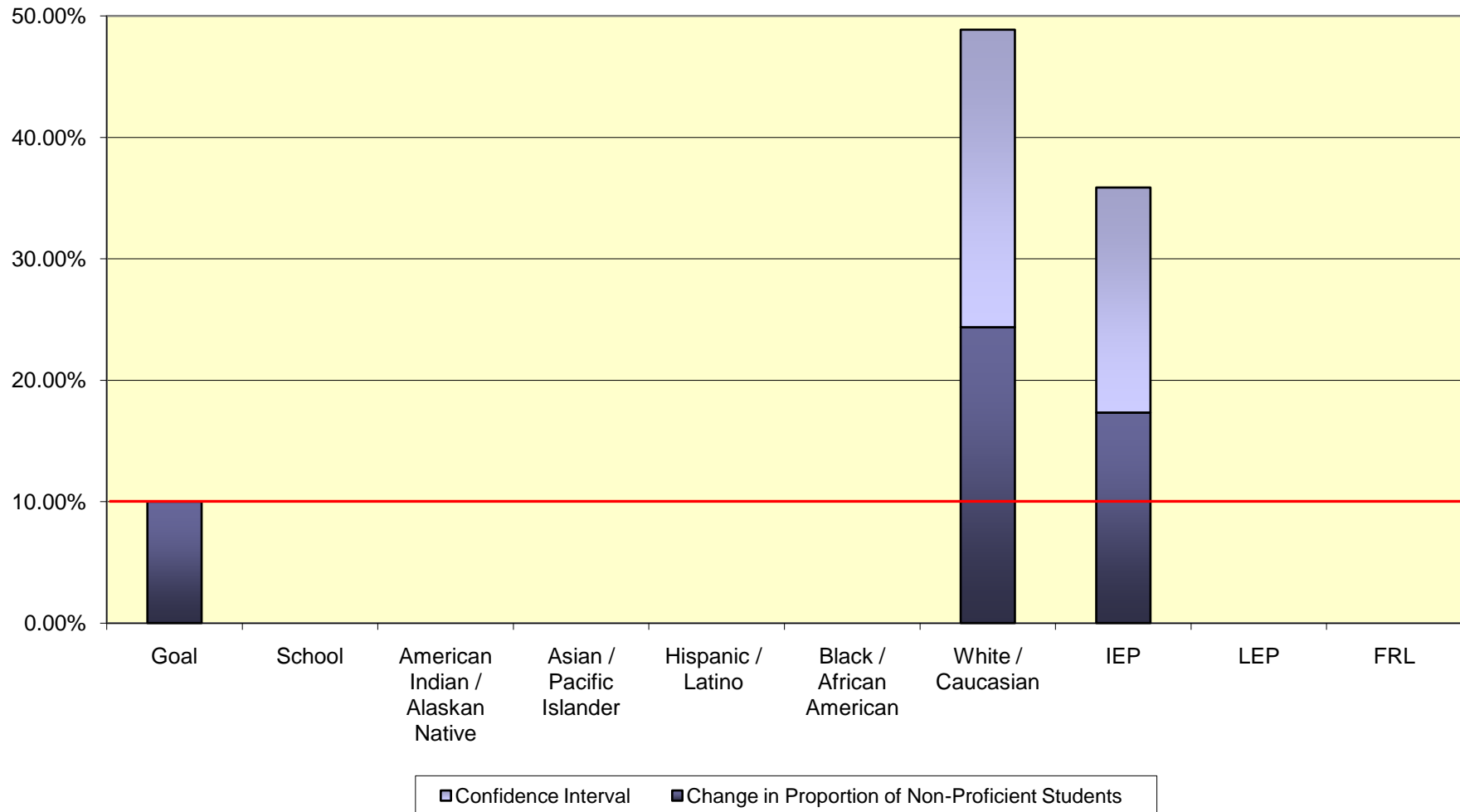
## 2008-2009 School Year ELA Reduction in Non-Profit Students
