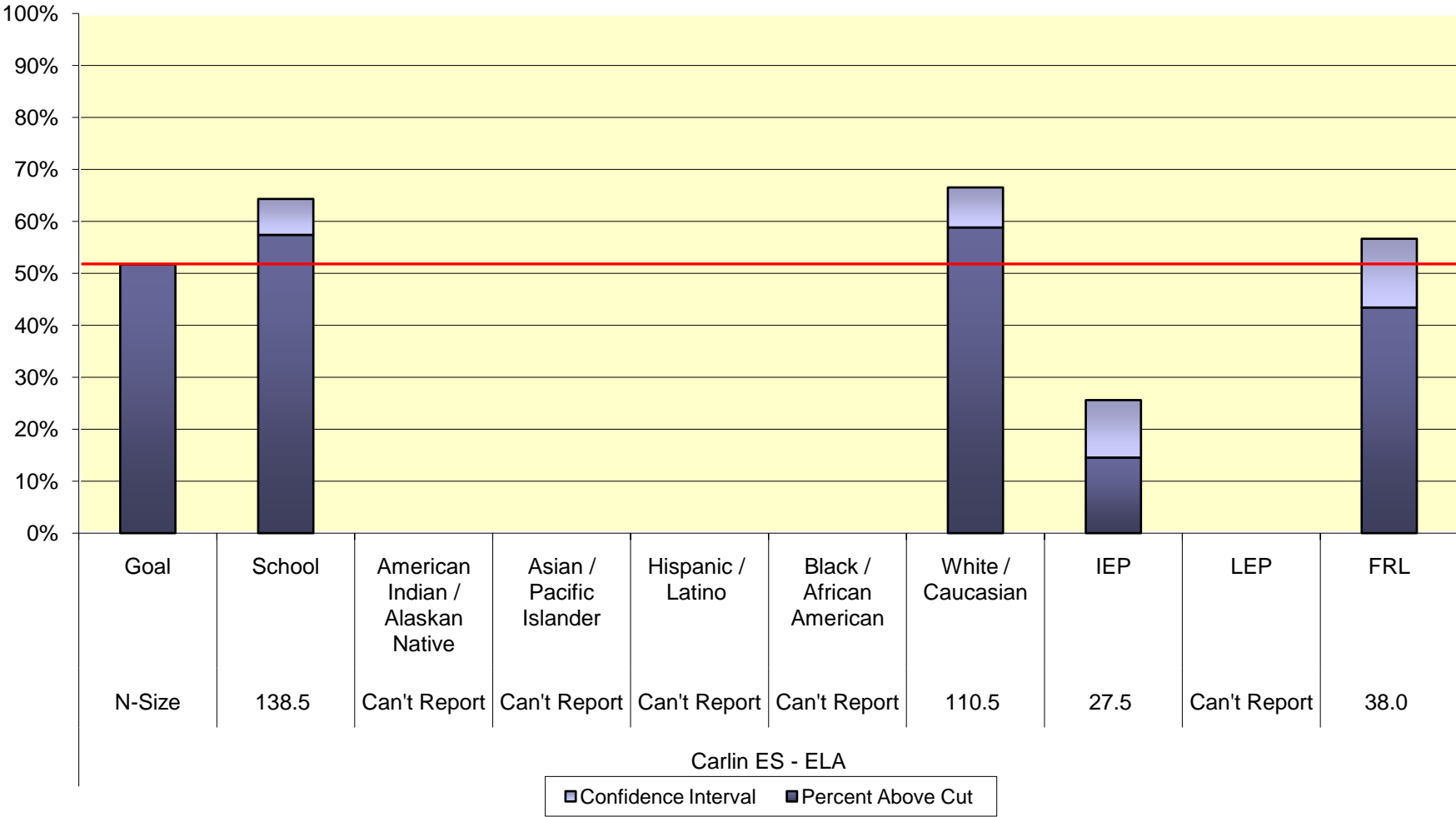

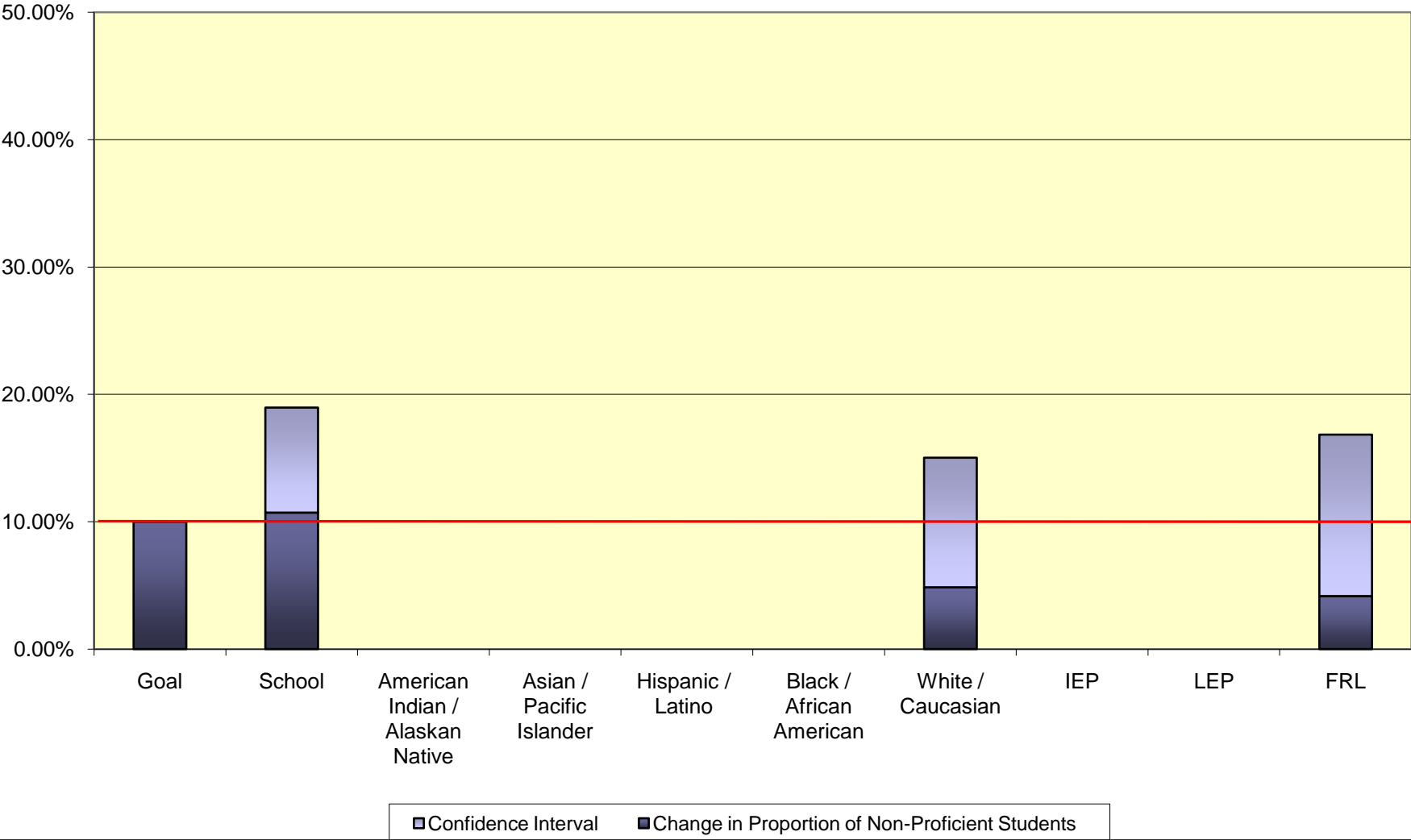

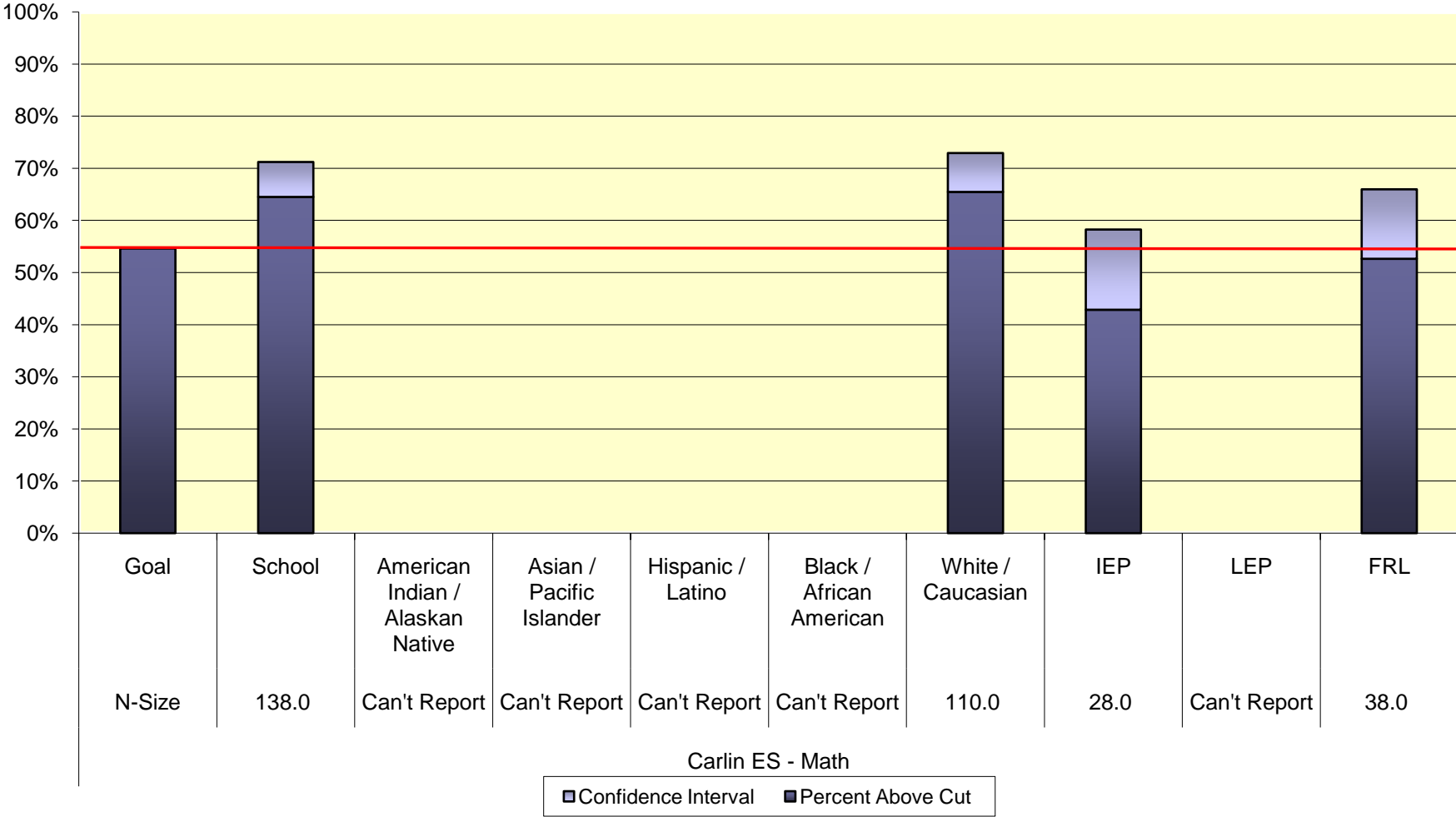
2008-2009 School Year ELA Status



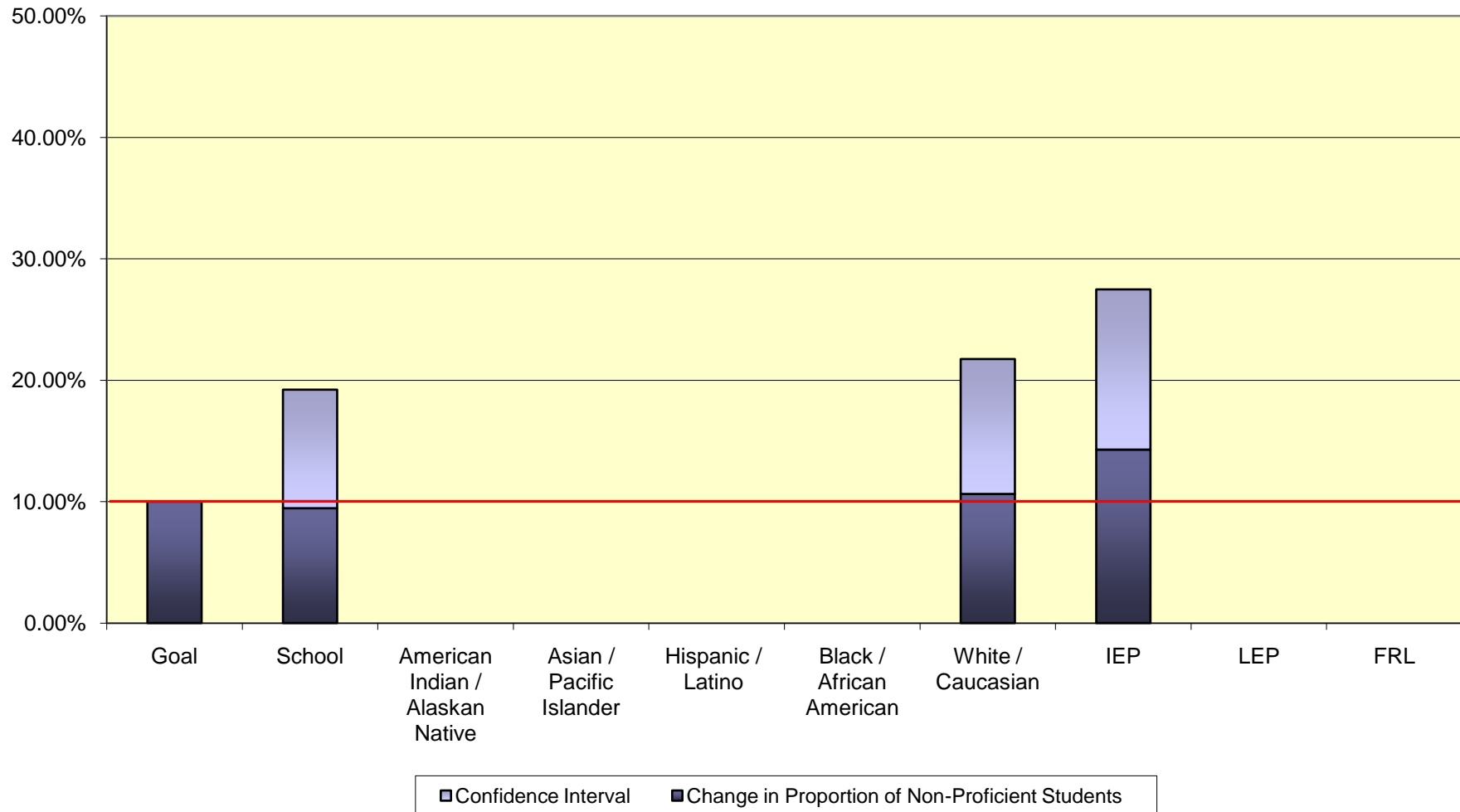
2008-2009 School Year ELA Reduction in Non-Proficient Students
