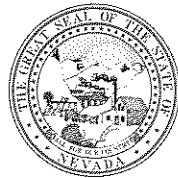

SUBJECT: Equipment Assistance Grant

USDA has announced the FY 2010 NSLP Equipment Assistance Grants and Nevada received \$169,425 to provide equipment assistance to school food authorities (SFA). For the purposes of this one-time appropriation, the term "eligible SFA" means a SFA:

1. participating in the NSLP established under the Richard B. Russell National School Lunch Act; and
2. that did **not** receive an ARRA grant for NSLP equipment assistance. Please note that SFAs receiving partial funds due to the ARRA recovery and reallocation of unliquidated funds process are not eligible for FY 2010 NSLP Equipment Assistance Grants.
